- Board licensees will receive an email containing the message that stresses the requirement that a Kentucky board approved Ethics course, and only a Kentucky board approved Ethics course, is required every renewal period. Failure to meet this requirement for renewal continues to be significant issue.
- KRS 12.245 became effective July 14, 2018, which requires a licensing board to issue a license, within 30 days of receiving a complete application, to a United States military service member or veteran who currently holds or recently held an equivalent license in another state. The board already issues the licenses to these applicants well before the 30-day deadline.
