Technology Standards in Social Work Practice

The board was given the new publication published by NASW, ASWB, CSWE and CSWA on *Standards for Technology* which covered topics such as: confidentiality with electronic records; provision of information to the public; ethical use of technology to deliver social work services; social media policy; access to technology and technological disruptions.

The board was also provided with *The ASWB Social Work Practice Mobility Implementation* as a resource for strategies to address mobility. In addition, the U.S. Department of Labor published a News Release announcing grants to help reform licensing requirements and increase portability.
