### **New Business**

Discussion was held by the board members regarding the new supervisor training courses. Dr. Miller informed the board that there appears to be sufficient amount of trainings for all supervisors to acquire the six (6) hour training by the January 2022 as specified in the regulation, 201 KAR 23:070.

Additionally, Dr. Miller encourages supervisees to attend the meetings as well. The supervisor and supervisee training may be taken in person, online, or on demand. The required supervision training is anticipated to be in operation by January 2022.

Attorney Nicole Bearse explained the House Joint Resolution 1 recently passed in September during the General Assembly Special Session. That order relates ONLY to out of state providers needing Emergency Permits to practice telehealth with clients located in Kentucky. Only those permits to practice are extended by this resolution. None of the other Emergency Orders made by the Board of Social Work due to the COVID-19 pandemic have been extended.

Executive Director Marc Kelly is exploring Thentia, a company that provides database management. This would allow for better organization and storage of board documents and would allow for better service for licensees. Mr. Kelly will meet with Thentia representatives and give an update at the next board meeting.
