Dear Mr. Creekmore,

The Kentucky Board of Social Work met on April 13, 2021 and discussed the above referenced complaint. After reviewing the complaint and your response thereto; the Board arrived at the conclusion that is set forth in this letter.

After considering the entire record before it, the Board finds that the record demonstrates that you failed to maintain confidentiality as described in 201 KAR 23:080 Sections 10 Confidentiality. Additionally, the Board finds that you failed in your responsibility to clients as described in 201 KAR 23:080 Section 3. This action constitutes a violation of KRS 335.150 (1) (e) for which action may be taken by the Board.

Based upon the information provided in the complaint, and your response, the Board has determined the appropriate disposition of the matter is to issue a written admonishment. **Accordingly, pursuant to KRS 335.150 (3), the Kentucky Board of Social Work hereby issues this Admonishment.**

A copy of this letter will be placed in your permanent file. Within thirty (30) days of your receipt of this letter you have the right to file a written response which will be attached to the letter and placed in the permanent file. Alternatively, you have the right, within (30) days of your receipt of this letter, to file a request for a hearing on this matter with the Board. If such a request is made, the Board will immediately set aside this written reprimand, file a formal complaint in regard to this matter, and set a date for this hearing.

If after a hearing the Board determines that there is competent evidence to believe that a statute or regulation which governs the practice of social work has been violated, the Board is not limited to issuing an admonishment, but is empowered under KRS 335.150 to institute any of the penalties provided for under that statute, including suspension, revocation, imposition of probationary or supervisory conditions upon your license, imposition of an administrative fee, issuance of a written reprimand, or any combination thereof.
